V. Programs Chair, Rob Speas – John Whitehead & Jackie Raley, Knox County Property Assessor's Office

Marine Corp in 1971, began working in the Assessor's office in 1972. Highest certification in the State of TN. Assessments must be revenue neutral. The County can not make or lose money. This means that the rate of \$2.12 is adjusted. Reappraisals occur every 5 years. Appraisal is 100% value of your house. Assessment is 25% of appraised value. Commercial is 40%. State law sets calculation. An average appraisal increase is figured countywide – this appraisal cycle 40%. Property value increase up to 40% will not see an increase. Increased rates originate from the Mayor's office. New revenue comes from new construction, that is how additional revenues are added to the County budget. 10-12k appeals. 215-2006 is the number for formal appeals beginning June 1, 2022. If you appeal, you need to provide information to support your appeal like comparable sales, appraisals. Real estate market drives appraisal values. National investment firms are coming to Knoxville and buying homes / subdivisions to lease. Home sales over asking price. Questions regarding regulations that will address investment firms, because there are no laws restricting this practice. Assessors meet regularly and they are having ongoing discussions with industry professionals. Is there a Senior exemption or income exception? 15 acres or more fall under the Greenbelt - value at market value, value what you can grow on the property (not actual use, but maximum use), State determines those values. Is there a Military Veterans exemption – only if they are disabled. Again, starts at the State level. Owner of rental properties receives offer letters regularly. Terry Hill spoke to constituents' inquiries about market value. Sage spoke to the need to review your home insurance coverage - increased values may impact your coverage.
